

Pedal with Pete Foundation Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to pedalwithpete.org and the Pedal with Pete Foundation, and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Pedal with Pete Foundation include pedalwithpete.org. The Pedal with Pete Foundation website is a news and information, donations, ecommerce site. By using the Pedal with Pete Foundation website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, the Pedal with Pete Foundation may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you donate to the Pedal with Pete Foundation or purchase the Pedal with Pete Foundation's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction, but it is not retained by the Pedal with Pete Foundation.

The Pedal with Pete Foundation may also collect anonymous demographic information, which is not unique to you, such as your age. We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) sending us an email message; (c) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. We do not retain any credit card or bank account information on our Site. We will use your information for communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

The Pedal with Pete Foundation collects and uses your personal information to operate its website(s) and deliver the services you have requested.

The Pedal with Pete Foundation may also use your personally identifiable information to inform you of other products or services available from The Pedal with Pete Foundation.

Sharing Information with Third Parties

The Pedal with Pete Foundation does not sell, rent or lease its customer lists to third parties.

The Pedal with Pete Foundation may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to the Pedal with Pete Foundation, and they are required to maintain the confidentiality of your information.

The Pedal with Pete Foundation may disclose your personal information, without notice, if required to do so by law, or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on the Pedal with Pete Foundation or the site; (b) protect and defend the rights or property of the Pedal with Pete Foundation; and/or (c) act under exigent circumstances to protect the personal safety of users of the Pedal with Pete Foundation, or the public.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by the Pedal with Pete Foundation. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Pedal with Pete Foundation website.

Children Under Thirteen

The Pedal with Pete Foundation collects the names of children who are registering for a Pedal with Pete Foundation sponsored youth activity, such as a Youth Registration or a Kids Fest Participant. This information is needed in order to complete the check-in process on the day of the event. Participation in such an event must be authorized by a parent or legal guardian, and all information related to a child is limited to content voluntarily provided by the child's parent or legal guardian.

E-mail Communications

From time to time, the Pedal with Pete Foundation may contact you via email for the purpose of providing announcements, promotional offers, alerts, confirmations, surveys, and/or other general communication. In order to improve our Services, we may receive a notification when you open an email from the Pedal with Pete Foundation or click on a link therein.

External Data Storage Sites

We may store your data on servers provided by third party hosting vendors with whom we have contracted.

The Pedal with Pete Foundation reserves the right to change this Privacy Policy from time to time. We will notify you about significant changes in the way we treat personal information by sending

a notice to the primary email address specified in your account, by placing a prominent notice on our site, and/or by updating any privacy information on this page. Your continued use of the Site and/or Services available through this Site after such modifications will constitute your: (a) acknowledgment of the modified Privacy Policy; and (b) agreement to abide and be bound by that Policy.
